Family Law Issues Affecting LGBT Couples and Their Children

(2 hours MCLE)

Presenters: Catherine Sakimura, National Center for Lesbian Rights; Deborah Wald, Wald Law Group; Amy Williams, Legal Services of Northern California

The rights of same-sex couples and their children have changed considerably in the last few years. Registered domestic partners now have nearly all the rights and responsibilities of marriage under California law, many same-sex couples married before the passage of Proposition 8, and many paternity presumptions now apply to same-sex partners. These families face unique legal issues because many of these laws are new and untested and because federal law does not recognize California domestic partnerships or marriages between same-sex couples. This workshop will address parentage and custody issues for LGBT parents, dissolutions, and LGBT families' eligibility for public benefits. The presenters will provide written materials on California LGBT family law and public benefits, as well as tips for working with low-income LGBT clients.

Foreclosure Issues in Family Law Cases

(2 hours MCLE)

Presenters: Maeve Elise Brown, Housing and Economic Rights Advocates; Bill Flanagan, Legal Aid Foundation of Los Angeles; Ana Storey, Legal Aid Foundation of Los Angeles

This session will introduce family law attorneys to the world of foreclosures. Through the use of real-life fact patterns, participants will learn about the foreclosure process, to spot issues, and to help their clients develop loss mitigation options.

Indian Child Welfare Act in Family Law Cases

(2 hours MCLE)

Presenters: Vida Castenada, Center for Families, Children, and the Courts; Ann Gilmour, Center for Families, Children, and the Courts

The Native American community is often among the poorest and most underserved of the legal services community, yet their issues can often be among the most complex. Currently there is a general lack of awareness of how the Indian Child Welfare Act may arise in family law cases. Failure to understand and fully comply with the requirements of the Indian Child Welfare Act in cases to which it applies can lead to severe negative consequences for Indian children and families. Therefore, it is important for legal service providers to recognize where the Act may apply and understand its requirements. This presentation will provide an understanding of the purpose and background of the Indian Child Welfare Act, explain how ICWA may arise in various family code proceedings, and explain the legal requirements of the federal and state law and how to comply with these requirements.

It will also include information on increasing cultural awareness in working with Native Americans to obtain necessary information to comply with ICWA.

***NEW* Family Law 101: Introduction to Family Law**

(2 hours MCLE)

Presenter: Kathryn Kirkland, State Bar of California

Family Law 101, presented by a distinguished expert family law attorney, provides a basic introduction to the practice of family law, with emphasis on serving limited-income clients. The session will cover family law terminology, applicable statutes, an overview of family law proceedings, with an emphasis on the practical means of achieving the client's goals, and basic substantive law regarding dissolution of marriage, division of property, spousal and child support, and child custody. *Note: This session is geared towards volunteer attorneys interested in pro bono work.*

Overview of Family-Based Immigration

(2 hours MCLE)

This program will provide an introduction to the family-based immigration system. The discussion topic will cover the differences between visa petitions filed by U.S. citizen and lawful permanent resident family members. The program will cover the procedural differences and the common bars to obtaining lawful permanent residence through the family-based visa system. In addition, the program will discuss forms of relief for mixed-status families, i.e., families that include U.S. citizens, permanent residents, and undocumented family members, and helping families avoid immigration scams.

How the Department of Child Support Services Can Help You

A panel of Agency attorneys will provide an introduction to and overview of the Agency's State and Federal mandates, a catalogue of our available services, and a review of our database interfaces with other government agencies. We will describe the advantages of our new state-wide system, our automated accounting through the new State Distribution unit, and the free online Guideline Calculator.

Unlocking the Mystery: The Relationship Between Child Protective Services, Juvenile Court, and Family Law Practice

(2 hours MCLE)

Presenters: David Meyers, Administrative Office of the Courts; Randall Harris, L.A. County Counsel; Lisa Ruttan; Sacramento County Child Protective Services

This workshop will provide an insiders look into the decision-making process of a social services agency. Taught by professionals working within the child welfare system, this workshop will explore how referrals are processed, who makes the decisions to act, which assessment tools they use, and why certain children and families are determined to be at a higher risk of abuse or neglect than others.

Legal Representation of Diverse Populations

(2 hours MCLE)

Presenters: Protima Pandey, Inland Counties Legal Services; Arlene Cordoba, Inland Counties Legal Services

This workshop will cover strategies to develop effective outreach, staff competencies and client communications; understanding when to use cultural practices as a part of your court case while representing diverse clients with different cultural practices; and special issues of culture, law and legal systems while representing immigrants, limited English proficient and other un-served and underserved clients.

Key Immigration Issues for Family Law Practitioners

This session will cover issues related to serving immigrants under LSC rules; potential sources of immigration relief for victims of domestic violence, sexual assault, trafficking, and other serious crimes (VAWA Self-Petitions, Battered Spouse Waivers, U and T Visas, Gender-Based Asylum, etc.); identifying red-flag warning signs when working with immigrants; and considering immigration law implications in developing family law case strategies.

Alphabet Soup: Public Benefits and Custody Choices for Children Living Apart From Their Parents

(2 hours MCLE)

Presenters: Brian Blalock, Bay Area Legal Aid; Alice Bussiere, Youth Law Center; Angie Schwartz, Public Interest Law Project; Kathy Siegel, Alameda County Public Defender

Custody choices have a significant impact on eligibility for public benefit programs, such as AFDC-FC (foster care benefits), AAP (adoption assistance), CalWORKS, Kin-GAP (Kinship Guardianship Assistance Program), SSI (Supplemental Security Income) and FICA/Chafee (transitional services for emancipating foster youth.) Using hypothetical cases and participant discussion, this session will explore how dependency, juvenile court guardianship, probate court guardianship, and adoption interact with eligibility criteria for these programs.

Securing Your Client's Interest in a Retirement Plan

(2 hours MCLE)

This session is "must know" for 2009 as it will examine 2009 attachments to the Judgment form which relate to retirement plans. The intention is to convince you that you do not need training in qdros (pension orders) to effectively use these attachments to bring the client's interest to the attention of the Plan. Also covered will be - what is a retirement plan? what is a qualified domestic relations order? what is PENSION PLAN JOINDER and is it still required? The answers are easy and the forms are designed for use with every Judgment.

Grandparent Guardianship Assistance for Self-Represented Litigants

(2 hours MCLE)

Presenters: Jean Moran, Glenn County Superior Court; Tammy Grimm, Glenn County Superior Court

Courts are experiencing an increase in the number of grandparents seeking guardianship over their minor grandchildren. This workshop will address challenges that grandparents face, propose solutions to assisting elderly clients through the legal guardianship process, and examine how technology can positively assist guardians in accessing the courts. SHARP's Guardianship video and use of teleconferencing will be explored, showing how emerging technologies can be a model for other self-help and legal providers in assisting this target group.

Advocating for Domestic Violence Survivors on CalWORKs

(2.5 hours MCLE)

Presenters: Kate Meiss, Neighborhood Legal Services; Jodie Berger, Legal Services of Northern California; Ariella Hyman, Bay Area Legal Aid

Family law practitioners often have clients who receive or are eligible for CalWORKs benefits. However, most practitioners do not understand the CalWORKs programs or the significant benefits and flexibility it can offer clients. This presentation will discuss the flexibility afforded by the Domestic Violence Waiver in eligibility for the CalWORKs program. It will also review rules and procedures to protect the client from increased or future violence. You will receive practical tips and resources to ensure your clients are protected and get the flexibility they need to remain safe. This session focuses on the eligibility (rather than the Welfare-to-Work) side of CalWORKs and is a complement to the subsequent session “CalWORKs Welfare-to-Work and Domestic Violence Survivors”, which focuses on the welfare-to-work requirements of the program.

Ethics Issues for Legal Services Providers

(2.5 hours MCLE - Legal Ethics)

The presentation will explore the application of legal ethics to family law practice. Topics will include conflicts of interest, dealing with clients of diminished capacity, confidentiality, and the duty of communication.

Elkins Family Law Task Force

This interactive session will allow conference participants to share their ideas with members of the Elkins Family Law Task Force, which is charged with conducting a comprehensive review of family law proceedings and recommending to the Judicial Council of California proposals that will increase access to justice, ensure due process, and provide for more effective and consistent rules, policies, and procedures.

Who’s Your Daddy?: Paternity Presumptions

How CalWORKs Welfare-to-Work Requirements Apply to Domestic Violence Survivors

(2.5 hours MCLE)

Presenters: Jodie Berger, Legal Services of Northern California; Minouche Kandel, Bay Area Legal Aid; Julie Rivera-Coo, Neighborhood Legal Services; Eve Hershcopf, Child Care Law Center; Kate Meiss, Neighborhood Legal Services

Individuals who receive CalWORKs benefits are subject to the program's welfare-to-work (WtW) requirements. Family law practitioners often have clients who are participating in welfare-to-work programs. This presentation will provide an overview of the CalWORKs WtW system and its rules, as well as explore the role of the family law practitioner in advocating for clients within the WtW system. It will discuss how to obtain "domestic violence waivers" of WtW rules, the range of activities in which clients may participate, including education and DV counseling, and eligibility and payments for child care, as well as transportation and mileage. You will receive practical tips and resources to ensure your clients are getting the funds to which they are entitled and a WtW program that will help them move towards self-sufficiency. This session focuses on the Welfare-to-Work side of CalWORKs and is a complement to the earlier session "Introduction to CalWORKs Eligibility."

Ethical Communication with Self-Represented Litigants

(2.5 hours MCLE - Legal Ethics)

Presenter: Lollie Roberts, Sacramento Superior Court

This interactive session will explore strategies for communicating with self-represented litigants in a court-based self-help program without running afoul of the ethical guidelines. Topic areas will include legal advice versus legal information and how to avoid ex parte communications. Audience participation is both encouraged and expected.

Move-Away Custodial Cases

(2.5 hours MCLE)

This panel of four experienced family law attorneys will discuss representing limited-income clients in move-away cases from both the perspective of custodial and non-custodial parents. Topics to be discussed include but are not limited to: an overview of applicable judicial standards in move-away cases; tips on preparing an effective Order to Show Cause and preparing an effective response; challenges of international move-away cases; the role of custody evaluations in move-away cases; and barriers created by limited financial resources.

UCCJEA Review

(2.5 hours MCLE)

Presenter: Bill Hilton, State of California Board of Legal Specialization

This will be a basic review of the Uniform Child Custody Jurisdiction and Enforcement Act, with a focus on domestic violence cases.
